Gift Aid Facts

Gift Aid Maths

Charities have special status in tax law. Charities can claim back the tax paid by a taxpayer on all donations.

+

Every Scout Group is a Charity.

+

All subs are treated as donations.

=

All Scout Groups can claim 25% (tax paid by parents) on all Subs paid for their members.

Gift Aid Facts

Example calculation of Gift Aid

- If you have 40 members in your group and each member pays £3 per week (for 45 weeks).
- Your group could be £1350 PER YEAR better off.
- You can claim back 4 years NOW...
(that's £5400 in your group's bank account in the next 3 months!)

1. In the First Name Box – put eg xxth Bolton Scout Group – preferably the name held for your group by The Scout Association (TSA)
2. Leave Surname Box – empty

4. Set your Password – note the rules – minimum 8 characters, upper & lower case letters and at least one numeral.
5. Repeat Password and make a note of it.
6. In the Additional Info box – put your name and contact phone numbers
7. Press Submit.

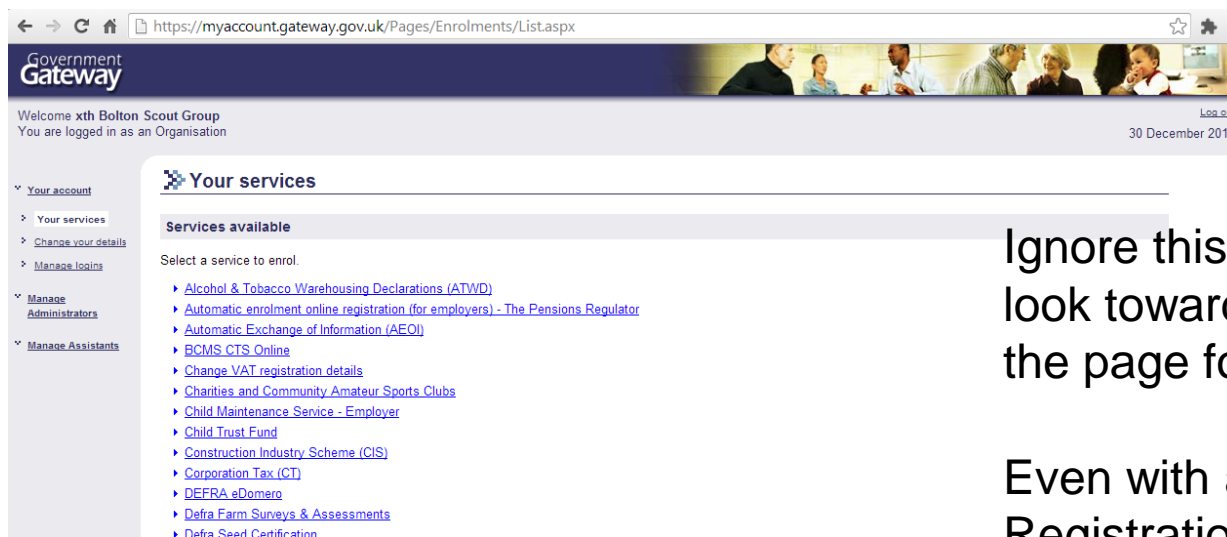


Step 1 Register with HMRC for Gift Aid Screen by screen online application

- Make a note of your Government Gateway Registration Number – 12 digits in 3 blocks of 4
- Check the box noting you have noted the ID
- Press Continue.
- This takes you to a 'Services Available' page

Ignore this page and now Log Out – look towards the top right corner of the page for the Log Out button.

Even with a Government Gateway Registration Number for your Group/District, you will not be able to make any further progress within this part of the Government web site.

Guidance Notes CHA1

You have to insert details about your group (see Slides 16 & 17)

- The people you are going to appoint to claim back the Gift Aid for you. This could be:
- Group Treasurer
- Group Secretary and another Trustee of your Group (See slide 18 for guidance).

You also need to gather some supporting documentation to assist HMRC to verify that you are a bona fide charity

- Your Group's annual income (from your last completed accounts)
- Your Bank Account details
- Documentation (see slide 17)

Preparation for completing the form

Section 6 - Responsible Person or Authorised Official

Scouts UK recommend 3 responsible persons. These ideally should be charity trustees within your group who have a current DBS clearances. Ideally they should be the Treasurer, Secretary and either Chairman or GSL. Their 'position within the organisation' is Trustee (all Trustees should have a current DBS clearance).



Ask them to provide the details requested on the form:

Title, First Name, Last Name, Date of Birth, Position within the Group or District, Daytime Telephone Number, Address, and previous address(es) if they have moved in the last 12 months, Post Code(s) and Country if NOT living in the UK and National Insurance Number. A Mobile Number and Email Address are optional



Once you have completed their details, print off the pages and ask them to check the details

Preparation for completing the form

Collect together all the supporting documents for your registration

Copies of bank statements

- Your Treasurer should receive monthly bank statements from the Group's bank. Ask them for the last 3 months' of statements (Print hardcopy and electronic copies - pdf).

Financial Accounts

- Your group is required to produce accounts at the end of each financial year. You should obtain hardcopy and create an electronic copy of the last full year's accounts.

Evidence of Activities

- Print off the form you submitted for the last Census plus supporting document (list of members) or the document you produced to upload member information to COMPASS

You then get a screen that allows you to submit the form to HMRC.

Print off the page labeled “**You’ve successfully entered your charity’s details**”

You then have 28 days to return specific hardcopy information as detailed to HMRC – do not send originals as they can’t return.

HMRC will subsequently issue a HMRC reference number for the group / district to the person named in Section 2 by post. Subsequently they will receive an activation code by post. This process can take up to 6 weeks.
